## **ORDINANCE**

AN ORDINANCE ("ELEVENTH AMENDMENT") BEING THE ELEVENTH AMENDMENT TO THAT CERTAIN ORDINANCE ("STREET LIGHTING ORDINANCE") CREATING SPECIAL DISTRICTS FOR PROVIDING STREET LIGHTING THEREIN, FOR THE LEVY AND COLLECTION OF SPECIAL ASSESSMENTS TO PAY THE COST OF PROVIDING STREET LIGHTING THEREIN, AND FOR OTHER PURPOSES, ADOPTED BY THE BOARD OF COMMISSIONERS OF LOWNDES COUNTY ON MARCH 27, 2018.
