Joseph Edward Vallotton (1875-1937) and his wife, Mattie Reese (1884-1961) began operating their dairy in Valdosta in 1910 with one cow. His business expanded to approximately 300 Holstein, Guernsey, and Jersey milk cows, ranging on 400 acres along Bonita Road. His sons, Hugh and Reese, began working with their father and adopting modernization methods by the 1930s, including the construction of a new facility in the 1940s.
