TRACT I:^{H18} One-half undivided interest in all that tract or parcel of land situate, lying and being in Lowndes County, Georgia, and being 34 acres, more or less, of Land Lot No. 29 in the Eleventh Land District of said county, and bounded on the north by the run of Mud Swamp, east by lands now or formerly of E. J. Wright, on the south by lands of J. O. V. Lineberger, and on the west by lands known as the old Lane property. This is the same property described in that certain deed dated November 21, 1937, from William James to J. O. V. Lineberger, recorded in Deed Book 35, at Page 593, and that described in that certain Executor's Deed of Relinquishment recorded in Deed Book 106, at Page 228, and that certain Quit-Claim Deed to Eugene E. Siocum, dated June 2, 1965, and recorded in Deed Book 106, at Page 241, all in the Lowndes County Georgia Deed Records.

TRACT II:^{H18} One-half undivided interest in all that tract or parcel of land situate, lying and being in Land Lots 28 and 29 in the 11th Land District of Lowndes County, Georgia, as shown on that certain plat of survey of land of J. O. V. Lineberger which appears of record in Plat Record Book 3, Page 268, in the Lowndes County Georgia Deed Records; provided, however, the southern boundary of said property is the southern original land lot line of said Land Lot 28 as established in that certain "land line agreement" between J. O. V. Lineberger and Harvey A. Dees, Arley Dees and Matella Dees, which appears of record in Deed Book 18, at Page 425, in said deed records, **LESS AND EXCEPT:** Right-of-way taken for Interstate 75. Said property in the aggregate contains 273 acres, more or less, and is divided into two tracts by Interstate 75. The portion of the property lying to the west of said Interstate 75 contains 237 acres, more or less, and is that property designated as Parcel 77 on Map 69 on the Tax Assessor's Record in Lowndes County, Georgia. The portion of the property lying to the east of said Interstate 75 contains 36 acres, more or less, and is depicted as Parcel 79 on Map 69 on the Tax Assessor's Record in Lowndes County, Georgia. All of said deed records and Tax Assessor's records are by reference incorporated herein for all purposes in aid of description.

TRACT III:^{H18} One-half undivided interest in all that tract or parcel of land situate, lying and being 51.6380 acres located in Land Lots 28 and 29 of the 11th Land District of Lowndes County, Georgia, and being more particularly described on that certain map or plat of survey designated "Property of Harold E. Myers" as prepared by S. Riley Kendall, dated October 12, 1992, and recorded on October 13, 1992, in Plat Record Book 36, Page 180, Office of the Clerk of the Superior Court of Lowndes County, Georgia, to which map or plat of survey is hereby referred in aid of description.
